B.ART - Arte in Barriera – The Public Jury

Abstract:

The international call for applications B.ART - Arte in Barriera, coordinated by the Fondazione Contrada Torino Onlus, as part of the Urban Barriera di Milano programme. The project is aimed at artists, graphic artists, designers and architects who want to propose a concept that can unfold like a story across thirteen empty facades of a number of buildings in the area, which were selected by the organisers and promoters following a long selection process and consultation with the building owners.

The choice of the eventual winner will be carried out according to a structured process in two distinct phases: the first will be conducted by an expert jury, and the second will be conducted by the same experts as well as a public jury from the local area.

The expert jury, who will be entrusted with the pre-selection of up to five proposals, will consist of three specialists from the three specific areas of the call for applications (contemporary art, graphic design and design) and two experts from local organisations and institutions.

The local jury: in order to extend participation on the part of the local community

from Barriera di Milano, the local jury is defined in such a way as to allow a wide involvement of all those who wish to play an active part in the selection process of the concept that will be placed across 13 walls.

There are four main criteria for the formation of the jury, which are: encouraging wide participation: involving different types of individuals representing the area; ensuring a formative period; proceeding by means of a draw should the number of candidates exceed the established maximum.

Wide participation: the local jury involves the participation of a maximum number of 37 members.

Type of subjects from the area. With the objective of widening participation as much as possible, but also in respect of the variety of interests and sensibilities that express the local area, it was decided to allow the composition of the local jury by identifying certain categories: residents, businesses, schools, students, associations / groups, as well as District 6 and the Urban Committee.

Formation: it was deemed appropriate to provide for a method that would allow all those who will assume the burden of the joint evaluation of the final order to receive a “handover of activities” from the jury of experts. A workshop is planned to illustrate

the pre-selected results from the jury of experts in order to enhance information and suggestions for further evaluation to be carried out by the local jury.

Drawing of lots: in the case of interest greater than the proposed maximum number of 37, it has been decided to proceed with a drawing of lots should the number of requests exceed the number of places available.

Rules of Local jury

Composition

The jury will be composed as follows:

- up to a maximum number of four representatives from District 6
- 1 representative of the Urban Committee
- up to a maximum of 13 representatives from buildings involved in the interventions (one per block)
- up to a maximum of 4 resident, living in the area*
- up to a maximum of 4 business owners based in the territory *
- up to a maximum of 2 teachers from the schools in the area *
- up to a maximum of 2 students (of age) attending secondary schools in the area *
- up to a maximum of 2 university students residing in the area *
- up to a maximum of 5 members of associations operating in the area *

(* The area of reference corresponds to the Urban Programme area and is between Via Sempione, via Bologna, corso Novara/Vigevano and corso Venezia)

As far as the representatives from the involved buildings, they must be indicated by ownership of the individual buildings: through a resolution of the general meeting of Condominium or through a proxy to a single signed by the majority of thousandth share of a property, for which a specific form will be provided.

As for the other categories (with the exception of Circostrizione 6 and Urban Committee), membership is free and open to all interested adult citizens.

The Jury is valid even if it is not composed of the maximum number of 37 members.

How to apply

Candidates must complete the Jury membership form, available to download from www.arteinbarriera.com or from the Urban Committee offices, corso Palermo 122 and send it by email or hand deliver it to the Urban Committee offices by 12:00 on 11 June 2014. Each single candidate may only fill out one form.

Selection of jury members

In the event that the requests for admission are higher than the number of places available, a draw will be held. The date of the draw, which will take place in public, will be announced on the site www.arteinbarriera.com

Evaluation methods

The evaluation involves three phases:

- a) Presentation of the works selected by the jury of experts
- b) Analysis of the proposals by the local jury
- c) Completion and delivery on the part of individual local jury members of the evaluation forms available from the organising secretary.
